Initial UNESCO Situation

UNESCO is recognized as a leader in eco-responsible behavior. One of the General Manager's priorities is to ensure that all employees minimize their environmental footprint while they conduct business.

UNESCO hoped to reduce their printing and copying costs. An internal audit also found that they needed increased visibility of their output environment and to better understand the needs of their users: A4 vs. A3, color vs. monochrome, downtime vs. excess capacity, etc.

What Prevented UNESCO from Changing?

UNESCO wanted to rationalize their printing and copying environment but found that each device was on its own monthly contract and maintenance plan, making coordination across all devices very difficult. This led to very poor visibility across their entire fleet – they had no knowledge of usage or actual costs.

Why Choose Watchdoc?

The solution needed to solve the UNESCO print and copy pain points that were identified by the internal audit: reduce environmental impact, reduce cost, increase visibility and responsiveness to end-user needs.

Additionally, the solution needed to be non-intrusive in the existing UNESCO Windows Print Server infrastructure and could not introduce additional security risks to their environment.
