

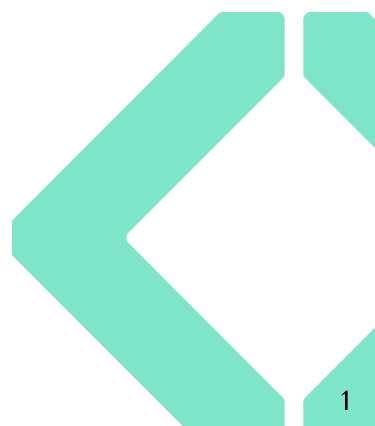

## 1 . Document security and availability

### Scanning

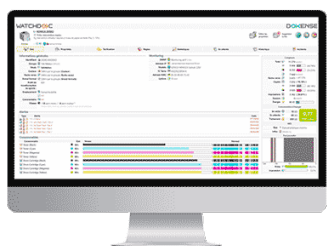
- User-friendly, multi-brand compatible scan interface

## 2 . Controlling and reducing costs

To understand, anticipate and control printing costs, you need visibility and tools to monitor and encourage more responsible consumption.



### Control

- Monitoring usage and the installed base
- Detailed usage statistics by site, department, user, etc.
- Detailed accounting, budget visibility and decision-making reports

### Regulation

- Voluntary or forced printing policy
- Savings calculator to validate your printing policy
- Integrated, customisable reports.

### 3 . Reducing waste and environmental impact

- Monitoring and auditing energy consumption

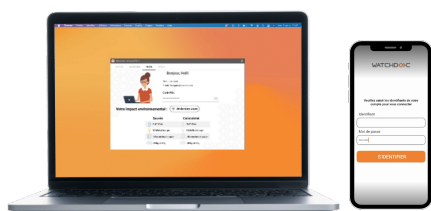
#### Raising user awareness

### 4 . Deployment and mobility\*

The solution needs to be flexible in order to best meet the needs of the largest and most complex networks. It must also be easy to use, so that it is readily accepted and has no impact on day-to-day tasks. It must be able to free itself from constraints and enable mobile working.

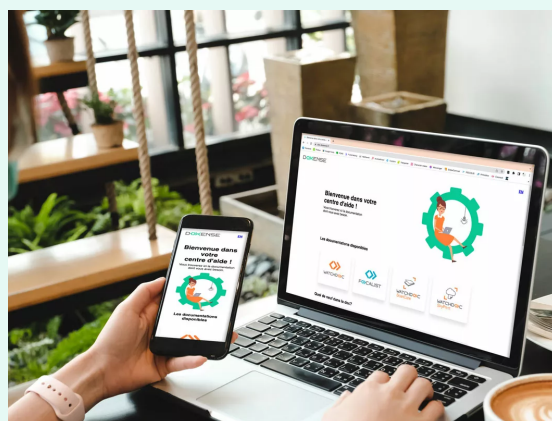
